ARTICLE 2: DURATION AND EVALUATION

- This MOU shall be in effect for a period of Five years from the last date of signature. Either party may request termination of this agreement, in writing, ninety (90) days prior to the proposed termination date. Any activities in progress at the time of termination shall be permitted to conclude as planned unless otherwise agreed in writing.

ARTICLE 3: NON-DISCRIMINATION
